

Statute – Version from 18.12.2016

§1 Name and official address of the organisation

1. The name of the Organisation shall be „LoveHurtsCrew“. The official address is in Berlin. A registration in the register of associations is considered. With this registration „e.V.“ will be added to the name of the Organisation.
2. The business year is the calendar year.

§2 Mission statement of the organisation

1. The aim of the „LoveHurtsCrew“ shall be the promotion and support of fan culture in esports, especially the team „Unicorns of Love“.
2. The aim is the support of Unicorns of Love in sportive and ideal aspect. The organisation offers the opportunity of common experience to watch the Unicorns of Love games, either live or in front of screens, as well as more common activities or festivity to grow together as an organisation.

In matters, which belongs to the Unicorns of Love, the interests of the member of the organisation shall be represented.

Any form of racism and violence is rejected. Fairness to each other and to anyone else is compulsive.

Misuse of alcohol and drugs is not tolerated. Political, ideological and religious aims shall be not pursued.

The social integration of foreign and disabled people shall be raised.

3. The organisation shall be autonomous; it shall be non-profit making and any excess of funds received or generated from its activities must always be reinvested in the same Organisation. Member of the organisation do not get donations from the organisation. No person shall be advantaged by any financial matter.

§3 Membership

1. All persons are eligible to become Members of the Organisation with full voting rights. An application for admission must be written to the Executive Committee. With this application any member is indebted to promote the mission statement of the organisation and also to pay the membership fee. A decision about the application is taken by the Executive Committee. It shall be only refused if there are any interests of the organisation opposed.

2. Underaged people need the signature of a parent or legal guardian.
3. Membership can be cancelled every time to the end of a month. For this is a written explanation to one member of the Executive Committee needed. The period of cancellation is 2 weeks. With cancelling the membership all requirements of already payed membership fees are expired. Although one member cancelled the membership the organisation is continued by the rest of the member.
4. Reasons to get excluded:
 - a. Act against mission statement.
 - b. If does not fulfil the obligations for the club and does not pay his membership fee for three month although there is a admonition.
 - c. Endanger the interests of the organisation.

The Executive Committee decides about any exclusion from the organisation.

5. In public every member has to act for dignity and aims of the organisation.

§4 General Meeting

1. Highest institution ist he general meeting. The Chairperson will preside at all and General Meetings of the Organisation.
2. The general meeting prepares rules of action and decides about questions which have a fundamental meaning.
3. The ordinary general meeting is once a year, during the first three month. Above the ordinary general meetings take place, when it is needed to keep the interests of the organisation.
4. The call for a general meeting needs to be written (letter or E-Mail) by the Chairperson or deputy chairperson minimum 10 days before the general meeting.
5. In the beginning of the general meeting a reporter is elected. Decisions of the general meeting are made with a simple majority (excluded amendments of the statutes and resolution of the organisation) and written down in the record. The record is signed by the Chairperson and the reporter.
6. The member accept the report from the Executive Committee about the last trading year with simple majority

§5 Executive Committee

1. The Executive Committee shall consist of Members who are at least 18 years old and live in Germany. If a member of the Executive Committee leaves the

organisation he also loses his place in the committee. A new voting for a new member in the Executive Committee takes place at the next General Meeting.

2. Parts of the Executive Committee are the Chairperson, the Deputy Chairmaster and the Treasurer. They are the Executive Committee as it is needed in §26BGB. The organisation is represented by the majority of the Executive Committee.
3. To the extended Executive Committee also belong 2 auditors and 2 PR-Agents.
4. All member of the Executive Committee do their job voluntary. The Executive Committee gets discharged in a General Meeting.
5. The Executive Committee represents the organisation in all judicial and non-judicial matters.
6. The Executive Committee shall be elected to office for a period of two years. by secret ballot, electing those Members obtaining the highest number of votes. The elections for the extended Executive Committee are annual.
7. The Executive Committee only can make obligations limited as high as the club funds. The authorization is restricted so far.

§6 Membership fee

1. The amount of the membership fee is annual fixed by the Executive Committee.

§7 Amendment of the statutes

1. About Amendments of the statutes, changing the mission statement and resolution of the organisation decides the General Meeting. Proposals for amendments of the statutes or changes of the mission statement have to be send to all member minimum 1 month before the general meeting takes place. For decisions there have to vote a $\frac{3}{4}$ -majority of the attendant member with „yes“.
2. Changings or Additions of the statute, which are required by the county court or the collection office are presented by the Executive Committee at the next general meeting. For implementation there also have to be a $\frac{3}{4}$ -majority of the attendant member.

§8 Resolution of the organisation

1. A resolution is only possible if the team we support („Unicorns of Love“) are resolved or if the general meeting decides to resolve with a $\frac{3}{4}$ -majority.
2. The residual assets is sent to a good cause.
